



**AMERICAN CANCER SOCIETY, OHIO DIVISION INC. –**  
Provides support and educational programs to cancer victims and their families. Funds research on a national level.

**AMERICAN NATIONAL RED CROSS –  
MERCER COUNTY CHAPTER –**  
Provides disaster relief services, CPR, and first aid classes, water safety classes, services to military families and Bloodmobile services. Most funds are kept in Mercer County.

**ARC OF OHIO IN MERCER COUNTY –**  
Provides services and support for persons of all ages with developmental disabilities in Mercer County and their families. ARC offers community-based activities, informative presentations and educational opportunities pertaining to specific disabilities. Works closely with Mercer Co. Board of Developmental Disabilities (Cheryl Ann programs) to advocate for and serve people with disabilities.

**BOY SCOUTS OF AMERICA - BLACK SWAMP  
AREA COUNCIL –**  
Performs community projects, helps mold young men into responsible adults.

**CANCER ASSOCIATION OF MERCER COUNTY, INC. –**  
Provides services and support to citizens of Mercer County affected by cancer, and promotes awareness of the disease. All money is used locally.

**CELINA ADULT DAY CARE -  
PRIVATE DUTY SERVICES, INC. –**  
Designed to assist those caring for aging or disabled family members by providing care during the day at the center and enabling caregivers to continue or resume employment. Provide mental and social stimulation for the clients and assistance with personal care as needed. All money is used locally.

**CENTER FOR NEUROLOGICAL DEVELOPMENT, INC.  
– ST. PETER**  
Provides “Free of Charge” therapy to brain injured children and adults. All money stays local.

**CHOOSING LIFE PREGNANCY  
RESOURCE CENTER, INC. –**  
Promotes the well-being and spiritual health of men, women and families in a pregnancy situation. Services include: Free pregnancy tests, ultrasound, counseling, information about pregnancy, abortion and fetal development, abstinence programs, adoption support and parenting classes.

**FAMILY CARE OPTIONS INC. –**  
Provide around the clock service and support to families of individuals with disabilities. Services range from a few hours each week to 24/7 care.

**FOUNDATIONS BEHAVIORAL  
HEALTH SERVICES, INC. –**  
Provides prevention, intervention, and treatment services for local children and families affected by abuse, neglect, addiction, and mental health problems. All money is used locally.

**HOSPICE-THE CARING WAY-  
COMMUNITY HEALTH PROFESSIONALS, INC. DBA –**  
Provides quality and dignified care for individuals dealing with terminal illness plus information and support for family members now and in the trying times ahead. All donated money is used locally.

**MED FOUNDATION OF MERCER HEALTH –**  
The Medical, Education and Development (MED) Foundation of Mercer Health was established to provide for enhancements and for educational support for the future of health care services within our community. The Foundation helps ensure that Mercer Health can continue to provide quality, local health care.

**MERCER COUNTY D.A.R.E. BOOSTERS –**  
Promotes drug and alcohol abuse education and prevention through a countywide network of school guidance counselors, teachers, and concerned citizens. All donated funds used for local school programs.

**MERCER COUNTY HISTORICAL SOCIETY, INC. –**  
Administers the Mercer County Historical Museum, which is visited by more than 5,000 guests each year. Provides tours for schools, and civic organizations, and offers scholarly programs on local and Ohio history, prints local history books and maintains an expanding history and genealogy archival collection.

MRSI is a regional non-profit agency that has over thirty-five years of empowering individuals with cognitive or mental health disabilities.
